Approximately 25 neighbors at the meeting.

- 1. David Chui
 - a. Has 21 bills moving through the legislature
 - b. Transportation
 - i. Bike and Car safety
 - ii. California is raising the gas tax, slightly raise the vehicle registration fee to have some of these fees go into public transportation
 - iii. he has a bill to think about water transit how do we get people to use ferries?
 - iv. speed cameras (automated speed enforcement)
 - 1. 70% of accidents in SF have happened on 12% of our SF streets (in the more dense areas like Mission) law enforcement unions stalled the bill because there is a concern about losing police jobs
 - c. Housing (David is the Chair of the Housing Committee)
 - i. Affordable housing bills have been veto'd by Governor Brown; he won't support affordable housing unless we think
 - ii. Cities like Brisbane, Lafayette, Santa Clara (recently sued for blocking affordable housing development in their city) are not doing anything to help build housing for the Bay Area
 - d. the "resistance"
 - i. what do we do to protect our residence if the affordable care act gets repealed
 - ii. what about environmental protections for California
 - iii. what about the diversity of our communities
 - 1. California is setting up a hate crime hot line
 - 2. Addressing bullying in the classroom Muslim community, LGBTQ
 - 3. sanctuary at home bill
 - a. Trump sending ICE agents to school campuses so he has a bill that prevents ICE agents coming to school campuses
 - b. Trump is paying 10,000 more ICE agents going into restaurants so David has a bill that allows restaurants to act as private enterprise (need to have search warrants)
 - c. 50% of agricultural workers in CA may be vulnerable
 - d. Open Hand
 - e. Single Payer Legislation (SB 562)
 - i. 5 million people could loves insurance overnight and blow a \$24B gap in our budget – California cannot fill those funds
 - ii. CA would need federal cooperation
 - iv. Question: in SF, 4% of the people are African America and yet 70% of the kids in the juvenile justice system are African American. What can we do to plug our kids into jobs locally? it has been shown that if African America kids get jobs early, they are much less likely to go to jail. (Susie Jones)
 - 1. recommends we all check out "old school café" in the Bay View

 - a. He is the chair of the assembly budget committee
 - i. investing in education
 - ii. we get \$20 B from the federal government; 5 million people have benefited
